# Verification Scope

**Operational Boundary:** The scope of the current verification process, as discussed with Ecovyst prior to the commencement of the verification activities is summarized below:

- Hazardous waste disposal
- Non-hazardous waste disposal
- Water withdrawal

**Organizational Boundary:** The organizational boundary of the verification was Ecovyst's global portfolio of facilities, including operating headquarters; manufacturing, administrative, research and development, office, warehouse, and testing facilities.

Chemical Boundary: CO<sub>2</sub>, CH<sub>4</sub>, and N<sub>2</sub>O

### Verification Activities & Limitations

The following activities were conducted during the Ecovyst's verification: AET reviewed the logic of the quantification document, including estimation methods; reviewed the completeness, accuracy relevance of the emission estimates, data management, supporting calculations, and emissions factors. The verification team reviewed the validity of the GHG inventory design, sustainability metrics and inventory boundaries. The Sustainability Performance Data was reported in Ecovyst's "ECVT 2021 & 2022 Export Water, Waste, Energy 4-3-2023" and "ECVT 2021 & 2022 Export ENERGY Only 5-4-2023". The AET verification team made efforts to identify any errors or misrepresentations in the items listed above and confirm that all errors were within the defined materiality threshold of ±5%.

# **Verification Opinion**

Based on the verification activities performed, AET concluded that Ecovyst's 2022 calendar year Sustainability Performance Data is:

- In accordance with the criteria of the GHG Protocol;
- Relatively free of material misstatements; and
